**ORDER:**

In the letter 2<sup>nd</sup> read above, the Commissioner of Labour, Telangana, Hyderabad on the recommendations of the Government of India, DIPP for implementation of Ease of Doing Business Scheme, has proposed for exemptions from the provisions of the Telangana Shops and Establishments Act, 1988 to ensure that the final Registration is granted within one day from the date of application and also to eliminate the requirement of renewal of registration.

2. The Government have examined the matter and decided that final Registration is granted within one day from the date of application and to exempt all the shops and establishments from renewal of Registration.

3. Accordingly, the following Notification shall be published in the extraordinary issue of the Telangana Gazette dated: 14.06.2019:

**NOTIFICATION**

“In exercise of the powers conferred under sub-section (4) of section 73 of the Telangana Shops and Establishments Act, 1988, Government hereby orders exemption for all shops and establishments from sub-section (2) of section 3 of the Act for issue of final registration certificate within one day from the date of uploading of application along with enclosures as may be prescribed and also exemption from section (4) of the Act for granting renewal of registration certificate subject to payment of annual fee by the employer for extending the validity of registration by 1<sup>st</sup> December of every year.
