INTER-STATE MIGRANT WORKMEN (REGULATION EMPLOYMENT AND CONDITIONS OF SERVICE) ACT, 1979.

No:GHR/2021/82/LBL/192020/510460/M3 :- WHEREAS certain draft rules were published as required by subsection (1) of section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (30 of 1979), at pages 42-2 to 42-3, of the Gujarat Government Gazette, Extra Ordinary, Part IV-A, dated the 31st March, 2021, under the Government Notification, Labour and Employment Department No: GHR/2021/24/LBL/192020/510460/M(3), dated the 26th March, 2021, inviting objection and suggestion from all persons likely to be affected thereby within a period of thirty days from the date of publication of the said notification in the *Official Gazette*:

AND WHEREAS no objection or suggestion has been received by the Government in respect of the said draft notification;

NOW, THEREFORE in exercise of the powers conferred by section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (30 of 1979), the Government of Gujarat hereby makes the following rules further to amend the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) (Gujarat) Rules, 1981, namely:-

- 1. (1) These rules may be called the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) (Gujarat) (Amendment) Rules, 2021.
 - (2) They shall come into force on the date of their final publication in the *Official Gazette*.
- 2. In the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service)) (Gujarat) Rules, 1972 (hereinafter referred to as "the said rules"), -
 - (1) in rule 11, in sub-rule (2), clause (xii) shall be deleted;

- (2) in rule 41, sub-rule (17) shall be deleted;
- 3. In the said rules, in rule 52, in sub-rule (2), after clause (b) the following proviso shall be added, namely, "Provided that such authentication may not be required in case of electronic payment.".
- 4. In the said rules, rule 54 shall be deleted.
- 5. In the said rules, in rule 55, sub-rule (2) shall be deleted;
