NOTIFICATION ISSUED BY LABOUR DEPARTMENT HARYANA Vide-No- I.R.-  
2/2023/22979-23109 dated 28<sup>th</sup> August 2023. REVISED THE RATES OF MINIMUM WAGES  
W.E.F. 01<sup>st</sup> July 2023.

I would like to Inform you that The Haryana Government Labour Department vide their Notification No- I.R.- 2/2023/22979-23109 dated 28th August 2023 has revised their Minimum Rate of Wages in respect of different scheduled employments with effect from the 01<sup>st</sup> July 2023 in the state of Haryana, which was previously revised vide by Haryana Government, Labour Department, Notification No I.R.- 2/2023/9838-9968 dated 26<sup>th</sup> April 2023. The Minimum Wages between the different categories will be as under:-

10	<b>Safai Karamchari in any employment</b>	This schedule employment category was declared invalid by Honorable Supreme Court order CWP No. 25328 of 2015 titled as "Gurugram Industrial Association and another Versus State of Haryana. Thus the wages not notified of this category. But in schedule employment in housekeeping will be eligible for getting minimum wages in same manners which is was earlier to notification dated 21.10.2015.

**Note: Past recovery/deduction on account of minimum wages for the category No.10 shall be allowed.**
